






Scope of Review Conducted by FRRB

FRRB conducts holistic review of the general purpose financial statements of enterprises and auditor's report with a view to determine, to the extent possible:


Compliance with
the generally
accepted accounting
principles in the
preparation and
presentation of
financial statements;

Compliance with the disclosure requirements prescribed by regulatory bodies, statutes and rules & regulations relevant to the enterprise; and

Compliance with the reporting obligations of the auditor.

Selection of Enterprises for Review

The Board reviews the general purpose financial statements and the auditor's report of the following:



Enterprises referred to it by any regulatory body like MCA, SEBI, C&AG, ECI etc.

Enterprises wherein serious accounting irregularities have been highlighted by the media reports.










TR - Dashboard

Review of Financial Statements

Supporting Regulators &

To bring transparency in financial reporting as well as to support regulators, during the year the FRRB has undertaken, as special cases, review of 29 general purpose financial statement and auditor's reports thereon as referred by regulators, based on media reports and other references received.



Review of financial statements of 185 enterprises selected on suo motto basis or as special case has been undertaken. The preliminary review of 171 enterprises has been completed by Technical Reviewers and review of 140 enterprises has been completed by Financial Reporting Review Groups. Review of 30 financial statements has been completed by the Board which include 20 Ind-AS based Financial Statements.


